**Payment and Refund Policy:**

The cost of the course is \$4,500.00. Payments can be made either by cash or check and payment in full shall be due and payable prior to the completion of the course. Should payment not be made in full by the end date all credentials will be held by Veterinary Allied Staff Education, LLC until all monies are paid. An Interest rate of 7% will accrue on the unpaid balance.

Refunds will be made on a percentage of amount paid to the time attended minus nonrefundable application fee. This refund policy is for those students who have completed 60 percent of the course or less. Students who have completed 61 percent or more of the course are not eligible for a refund.

The total hours for the program are 306. The cost of the program is forty-five hundred dollars (\$4,500.00). Calculated according to CEC 94820 and 94931, this equates to \$14.71 per hour. Therefore, if a student attends 48% of the course the refund would be, cost of the program (\$4,500.00) less their obligation (48% of 306 hours x \$14.71 + 100.00 non-refundable deposit).

*Example:*

48% of 306 hours = 146.88 hours x \$14.71 = \$2160.61 + \$100.00 = \$2260.61. Total cost of program \$4500.00 - students obligation \$2260.61 = student refund of \$2239.39.

VASE, without penalty or obligation, shall refund 100 percent of the amount paid for course charges, less the application fee of one hundred dollars (\$100), if notice of cancellation is **made prior to or on the first day of instruction.**

Students who have not attended the first week of class will be dropped from the program. A refund at a prorated scale of the tuition will be provided, except for the non-refundable registration fee. The student may reapply for the next Alternate Route, RVT Program without an additional registration fee. This is a one-time only consideration. Students must maintain a "C" average to be eligible for course completion.

The Institution shall pay or credit refunds due on reasonable or timely basis, not to exceed 30 days following the date upon which student's withdrawal has been determined.

Veterinary Allied Staff Education, LLC does not participate in the Student Tuition Recovery Fund (STRF).
